Central New York Library Resources Council, the CNYFi program, and Onondaga County Public Library (collectively the "Library") has chosen to loan you the Kit with the Kit ID Number set forth above (the "Kit") so you and/or your household can access the Internet from home. This Kit includes a device to create a wifi network (the "Hotspot") and a computer to use on that network (the "Computer"). You understand that your household's use of the Kit is subject to the terms and conditions set forth in this Kit Loan Agreement, and by accepting the Kit, you and your household agree to the following terms and conditions:

1. I need to have a valid library card with no outstanding fines in order for my family to be eligible for this offer, and I agree to present documentation required to obtain a library card.
2. I understand that the Kit should be returned to the Library three weeks from the date of borrowing and may be renewed for a period of up to three weeks.
3. If the Kit is lost or not returned within two weeks after the second overdue notice, I will be charged a fee of \$100 for the Hotspot, and \$100 for the Computer; my wireless service will be terminated and all items in the Kit will become unusable; and my library card privileges will be blocked until all items are returned in working order or the fine is paid.
4. I understand that when accessing the Internet through the Hotspot, my family and I are accessing the Internet through Sprint's network and not the Library's network. My family's use of the Hotspot is subject to Sprint's Acceptable Use Policy, Privacy Policy, and Terms of Use, all of which are available on Sprint's website (currently located at [www.sprint.com/legal/agreement.html](http://www.sprint.com/legal/agreement.html)). Please read these documents before using the Hotspot.
5. I understand that the Library is not responsible for any files, data, or personal information accessed/transmitted using the Kit.

6. I understand that the Hotspot uses Sprint's content filter powered by Symantec. It is meant to restrict access to pornographic and phishing websites. I understand, however, that no filter can protect against all objectionable sites, and it is my responsibility to monitor and determine what is appropriate for myself and my family.
7. The Kit and its contents remains the Library's property at all times. The Library may request that I return the Kit at any time.
8. I will never loan out any items in the Kit to other individuals.
9. I will know where all items in the Kit are at all times.
10. I will not disassemble nor attempt to repair the Hotspot and/or Computer
11. I will take care of the Hotspot and Computer and will use reasonable efforts to avoid damaging the Hotspot and Computer. If the any item in the Kit is lost, stolen, or damaged, I agree to call 315-446-5446, Monday–Friday, 8:30 AM–4:30 PM or visit the Library where the Kit was borrowed. I understand that the Library may choose not to replace or repair the Kit at its sole discretion.
12. Technical support for the Hotspot can be reached by calling Manage Mobility Technical Support (below), seven days a week.
13. I understand that the Computer is meant to be used only with the Hotspot, and should not be connected to any other network. I understand that the Library is not responsible for anything that happens if the Computer is connected to any network other than the one created by the Hotspot.
14. I understand that the Library may use any appropriate means to collect the Kit and amounts owed to the Library due to failure to return Kit by the Kit Due Date.
15. I agree to return the Kit and all parts and packaging to the Library in good working condition.
16. I understand that the Onondaga County Public Library may decide not to renew my loan of the Kit.
17. I agree that the Library, its funders and other third parties selected by the Library may use any and all information collected about the usage of the Kit that I have borrowed to research, track and analyze the results and the effectiveness of the CNYFi program. By borrowing the Kit, I consent to the Library contacting me about my use and my household's experience with the CNYFi program.
